

ERNEST H. BALL and FRAYDA S. BLUESTEIN AWARD FOR EXCELLENCE IN MUNICIPAL LAW

The Award for Excellence in Municipal Law was established in 1991 by the Past Presidents Group of the North Carolina Association of Municipal Attorneys. Originally known as the Distinguished Service Award, in 1994 it was renamed in honor of Ernest H. Ball, former General Counsel of the North Carolina League of Municipalities.

On August 7, 2021, by a unanimous vote of the membership, the award was renamed the Ernest H. Ball and Frayda S. Bluestein Award for Excellence to honor Frayda Bluestein in advance of her retirement from the UNC School of Government.

Now nicknamed the "Ball-Bluestein Award," this award is intended to recognize persons who have made valuable contributions to the field of municipal law, whether through a single accomplishment or through an entire career. This award is to be given on the basis of achievement and not merely to honor an individual. A nominee does not have to be an attorney, and the Award is not necessarily intended to be presented annually, as the Association reserves the right not to make a presentation in any given year.

Nominations may be made to Jennifer Schneier, General Counsel of the League of Municipalities, who will present the nomination to the Board of Directors for approval. Nominations should include background information or supporting materials such as a letter of recommendation. Upon approval by the Board of Directors, the recipient will receive the award at the summer conference.
